#### 1 Purpose

This compliance report details the progress of Metro Mining Limited (Metro) against the requirements outlined in approval EPBC 2014/7305. For the purposes of reporting, Metro has elected to report on a financial year basis.

#### 1.1 Background

Metro operates the Bauxite Hills Mine (BHM) comprising the tenements controlled by three entities, Aldoga Minerals Pty Ltd, Cape Alumina Pty Ltd and Gulf Alumina Pty Ltd. For reporting and administration purposes, Gulf Alumina Pty Ltd tenements will be referenced to as Skardon River and Aldoga Minerals Pty Ltd and Cape Alumina Pty Ltd tenements will be known collectively as Bauxite Hills.

This Plan is specifically for the BHM Skardon River tenements which are located on Cape York Peninsula, in the Parish of Skardon within the Cook Shire. The BHM site is located approximately 85 km north of Weipa and approximately 35 km to the north of Mapoon.

The Skardon River tenements are operated under a State environmental authority for mining (EPML00967013), and as well as Commonwealth approval, decided under sections 130(i) and 133 of the EPBC Act.

The Skardon River tenements includes open cut operations, haul roads, bauxite stockpile and barge loading facility, materials offloading facility, transhipping activities and accommodation camp.

Bauxite product from the Skardon River tenements is transported via haul roads to the infrastructure at the Port of Skardon River and transhipped by barge to bulk carriers in deep water beyond the mouth of the river for export.

The BHM Skardon River tenements consist of three mining leases:

- ML 6025
- ML 40069
- ML 40082.

#### 1.2 Objective

This report addresses condition 20 of EPBC 2014/7305, namely:

Within three (3) months of every 12 month anniversary of the commencement of the action, the approval holder must publish a report (the Annual Compliance Report) on its website addressing compliance with each of the conditions of this approval, during the previous 12 months. Documentary evidence providing proof of the date of publication must be provided to the Department at the same time as the Annual Compliance Report is published. Reports must remain published for the life of the approval. The approval holder must continue to publish the Annual Compliance Report each year until such time as agreed to in writing by the Minister.

#### 1.3 Scope

This report details the approval conditions outlined within EPBC 2014/7305 and assessment of compliance against these conditions for the reporting period 1 July 2022 to 30 June 2023.

No amendments to approval conditions occurred during the reporting period 1 July 2022 to 30 June 2023.



#### 1.4 Designations to Record Findings

#### 1.4.1 Assessment of Compliance

The terminology used to record findings in the compliance report (see Table 1-1) is consistent with that described in Annual Compliance Report Guidelines (DotE, 2014).

**Table 1-1 Compliance Status Terminology**

#### 1.4.2 Compliance Status

Three non-compliances with respect to approval conditions 20, 22 and 28 were identified during the reporting period 1 July 2022 to 30 June 2023.

The non-compliances are in respect to Metro being unable to make available previous compliance reports and approved management plans due to a malicious cyber-attack on its website.

The non-compliances were resolved 14 July 2023.

A detailed assessment of compliance with the conditions of EPBC 2014/7305 is presented in Table 1-2.
